Big 7 Directly Operated Adult Full Service Partnership Program Staffing

Upon receiving State approval for the Mental Health Services Act, Community Services and Supports Plan, the Department will augment the existing staffing of the Big 7 Assertive Community Treatment (ACT) programs with staffing configurations approximating either one of the scenarios listed below. The staffing patterns scenarios differ only in whether Senior Community Mental Health Psychologists and Clinical Psychologist II's are budgeted versus Supervising Psychiatric Social Workers and Psychiatric Social Worker II's. Scenario 1 will be used for teams that will provide more trauma-focused treatment, Cognitive Behavioral therapy and Dialectical Behavior Therapy.

Scenario 1

Budgeted Payroll Title	Function/Role on team
Senior Community Mental Health Psychologist	Team leader providing clinical and administrative supervision to a multi-disciplinary team, including psychologists who will be providing specialized Cognitive Behavioral Therapy interventions to enrolled clients who are trauma victims.
Clinical Psychologist II	Will provide specialized services for clients who are victims of psychological trauma, a focal population identified by the State and the DMH Stakeholder group. These services will include Cognitive Behavioral Therapy and other short term treatment for Post Traumatic Stress Disorder. Psychologists will also conduct psychological testing, as appropriate, for differential diagnostic purposes and to aid in clinically-informed SSI applications.
Community Worker	Peer advocate. By virtue of the fact that this staff is a client in recovery from a mental illness, this staff will act as a role model for clients in their own recovery process. This staff will assist clients in the practical details of transitioning to employment or educational opportunities as well as transitioning to independent living. This staff will also assist the team with outreach and engagement efforts to enroll clients.
Intermediate Typist Clerk	Will answer phones, greet clients, file, Xerox, process and create documents, enter IS units of service
Senior Typist Clerk	Will oversee the process of outcome data entry, including aggregating and entering key event indicator data for all enrolled clients. This data is collected upon enrollment for the 12 months prior to the client's enrollment and anytime any indicator changes for a particular client. This staff will provide the team with monthly reports on client outcome data and ensure its accuracy. This staff will be the team's main contact for outcomes data and will work closely with the DMH outcomes unit.
