A Road Map to Transforming DMH Adult Systems of Care Programs

By July 1, 2005, each adult directly operated program will implement significant recovery and outcome-oriented changes in services to clients that are consistent with the Mental Health Services Act. In order to enhance the overall success of the transformation, Centers will be responsible for varying levels of transforming, based on the level of readiness. Programs are listed below, accompanied by the programmatic changes to be implemented by July 1st:

Transformation expectations of all adult programs:

- > If not currently in practice, creation of a consumer council that is chaired by a consumer(s) and meets monthly to address overall program and service planning.
- > Creation of and effective linkage to consumer-run groups and services.
- > At least one Wellness activity per day for clients to attend.
- > The presence of individual and group mental health services for clients with cooccurring disorders that are geared toward stage of recovery.

- > The development of a collaborative integrated mental health and substance abuse treatment program.
- > Antelope Valley Mental Health Center Basic transformation expectations.
- > Palmdale Mental Health Center Basic transformation expectations.

- > West Valley Mental Health Center Basic transformation expectations.
